#### **DESCRIPTION**

A research-oriented course that will allow students to synthesize their training in East Asian languages and cultures and bring it to bear on a particular subject in Chinese, or on the relation between East Asian languages and their respective cultures. Students will meet with the instructor individually and regularly in order to discuss their respective research projects.

Upon successful completion of this course, students will be able to:

- Understand key issues in second language research
- Demonstrate knowledge in second language research methods
- Develop skill in conducting second language research projects
- Develop skills and confidence in presenting research
