DESCRIPTION: Il s'agit d'une rétrospective des principaux courants littéraires français. Ce cours vise aussi à étudier les principaux auteurs qui ont marqué la littérature française depuis ses débuts. Les grands genres littéraires comme le roman, le théâtre, la poésie et le conte littéraire seront tous examinés et on fera constamment le lien entre l'histoire de la France et la littérature correspondant à chaque période.

OBJECTIVES: L'étudiant (e) qui complétera ce cours avec succès saura:

- 1. Situer dans le temps plusieurs grands écrivains français.
- 2. Distinguer et situer dans le temps plusieurs grands courants esthétiques de l'histoire littéraire française.
- 3. Expliquer et utiliser plusieurs concepts fondamentaux appartenant aux études littéraires.

OUTCOMES: À la fin de ce cours:

- l'étudiant (e) devra être en mesure de situer les grands courants littéraires dans leurs époques et de reconnaître les écrivains associés avec ces mouvements littéraires.
- L'étudiant (e) sera aussi capable d'utiliser les outils fondamentaux aux études littéraires en général.

REQUIRED COURSE MATERIALS:

• Chronologie de la Littérature française : du Moyen Âge à nos jours de Johan Faerber. Ce livre est obligatoire. Il est disponible à la librairie de l'Université.



In addition students will require:

- A computer with a supported operating system, as well as the latest security, and malware updates;
- A current and updated web browser;
- Webcam/Camera (built-in or external);

COURSE NOTES:

- 1. Class will meet on Monday/Wednesday/Friday from 1:00pm-1:50pm via Zoom.
- 2. Please consult D2L regularly. I will post a detailed class schedule along with dates for assignments and online tests. In addition, you will also find support documents and powerpoints to help you with this course.
- 3. Assignments should be submitted in the Drop Box (D2L) on the specified date. I will deduct 10% for all late assignments. Missed assignments will be given a grade F. While grading assignments 20% of the marks will be for the language and 80% for the content and analysis. Date of submission for the assignment for this course is **December 9, 2020**.
- 4. There will be two quizzes in this course (to be set up inD2L). The dates for the quizzes are October 9, 2020 and November 16, 2020. The quizzes will be designed to be completed during the duration of the class time (e.g. a 50-minute class would have a quiz designed to take no longer than 50-minutes to complete). Students will have the option to start the quiz at a time that best suits their situation within a 24-hour time period. Both quizzes will be an open book exam. Students will have access to their textbooks and their class notes for the two evaluations. - 5. **Individual Oral presentations** will start from the week of **October 19, 2020** (via zoom during class hours).

ASSESSMENT:

- 1. 2 Tests (2x20) = 40% (October 9, 2020 and November 16, 2020) (will be set up in D2L)
- 2. 1 Présentation orale (individuel)= 20% (starts from the week of October 19,2020) (Zoom)
- 3. Travail Final= 30% (to be submitted on December 9, 2020) (Drop Box, D2L)
- 4. Participation=10% (contribution to class discussions, well prepared for class)

The official grading system (A=4, B=3, C=2, D=1) will be applied for the calculation of the final mark.

Students are recommended to consult the University's explanation of the grading system http://www.ucalgary.ca/pubs/calendar/current/f-2.html which clearly states that B is awarded for an "above average performance" and that A is reserved for "superior performance". Marks of B+ or higher in the dissertation or oral presentation will require a high degree of originality in the treatment of the topic.

Active participation is defined as being consistently well prepared for class and contributing to class discussions on a regular basis.

Academic misconduct

- 1. **Plagiarism** is a serious offence, the penalty for which is an F on the assignment and possibly also an F in the course, academic probation, or requirement to withdraw. Plagiarism exists when:
- a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test);
- b) parts of the work are taken from another source without reference to the original author;
- c) the whole work (e.g., an essay) is copied from another source, and/or
- d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted." Plagiarism occurs not only when direct quotations are taken from a source without specific acknowledgement but also when original ideas or data from the source are not acknowledged. A bibliography is insufficient to establish which portions of the student's work are taken from external sources; footnotes or other recognized forms of citation must be used for this purpose.

2. **Cheating** at tests or examinations includes but is not limited to dishonest or attempted dishonest conduct such as speaking to other candidates or communicating with them under any circumstances whatsoever; bringing into the examination room any textbook, notebook, memorandum, other written material or mechanical or electronic device not authorized by the examiner; writing an examination or part of it, or consulting any person or materials outside the confines of the examination room without



permission to do so, or leaving answer papers exposed to view, or persistent attempts to read other students' examination papers.

- 3. Other academic misconduct includes, but is not limited to, tampering or attempts to tamper with examination scripts, class work, grades and/or class records; failure to abide by directions by an instructor regarding the individuality of work handed in; the acquisition, attempted acquisition, possession, and/or distribution of examination materials or information not authorized by the instructor; the impersonation of another student in an examination or other class assignment; the falsification or fabrication of clinical or laboratory reports; the non-authorized tape recording of lectures.
- 4. Any student who voluntarily and consciously aids another student in the commission of one of these offences is also guilty of academic misconduct.
