DESCRIPTION

Tel que le « mode d'intervention dans le social » (Fortin, 2006 : 12) qu'elle incarne, la revue est une manifestation concrète du désir d'entrer dans l'action; elle représente un lieu où les intellectuel.les autant que les groupes populaires expriment et développent leurs idées. Comme lieu de sociabilité, elle permet aussi le regroupement et l'échange si, selon la politique éditoriale, elle est ouverte au dialogue. Ce cours vise à initier les étudiant.es aux différentes revues culturelles québécoises depuis 1934 avec la création de *La Relève* jusqu'à celle de *Contre-jour* (2003). Il s'agira aussi de déterminer la fonction de ces revues dans le champ intellectuel québécois à partir des objectifs que se donnent d'atteindre les équipes de rédactions et les collectifs fondateurs des revues dans leurs éditoriaux programmatiques. On tentera en outre de saisir les résonances qu'ont créé ces prises de position dans les champs littéraire et culturel sur le plan des pratiques, des idéologies, des réseaux de sociabilités littéraires et de la formation de la figure même de l'intellectuel.les au Québec en considérant, comme Marie-Ève Thérienty, que « le journal constitue le point d'ancrage d'une forme de sociabilité due à son mode même de fonctionnement et de rédaction » (Thérienty, 2007 : 62). Ainsi, nous verrons comment les revues d'idées au Québec ont permis de cristalliser la présence de groupe précis dont l'idéologie intervient de manière singulière à des périodes charnières de l'histoire du Québec.

Il s'agira, en quelque sorte, d'un cours panoramique, mais qui sera soumis à la dynamique d'un séminaire, c'est-à-dire pour lequel la discussion permettra aussi de fonder la matière et la réflexion. On tentera par ailleurs de rattacher les questions particulières qui concernent la production de revues culturelles aux grandes problématiques de la société, de la culture et de la littérature québécoise.

Objectifs

- Prendre connaissance du corpus des revues culturelles (et d'idées) au Québec;
- Prendre connaissance, à travers elles, de l'histoire des idées et de sa progression;
- Prendre connaissance de l'histoire des intellectuel.les;
- Se familiariser avec le concept de sociopoétique des revues;
- Considérer la diversité du corpus en fonction des enjeux culturels, discursifs, esthétiques, formels, idéologiques et politiques qu'elle soulève;
- Comprendre les conditions particulières qui incombent à la production de revues culturelles;
- Se familiariser avec les grandes problématiques de l'écriture en revue et en identifier certains traits caractéristiques ;
- Perfectionner l'expression orale et écrite en français.

Habiletés requises

- Très bonne connaissance du français écrit et parlé.
- Très bonne connaissance des bases de l'analyse littéraire.
- Connaissance de certaines perspectives théoriques en études littéraires (histoire littéraire, sociocritique, sociologie de la littérature, analyse du discours et rhétorique).
- Connaissance avancée de la méthodologie de recherche en études littéraires

ACADEMIC MISCONDUCT

1. **Plagiarism** is a serious offence, the penalty for which is an F on the assignment and possibly also an F in the course, academic probation, or requirement to withdraw. Plagiarism exists when:
 - a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test);
 - b) parts of the work are taken from another source without reference to the original author;
 - c) the whole work (e.g., an essay) is copied from another source, and/or
 - d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted."

Plagiarism occurs not only when direct quotations are taken from a source without specific acknowledgement but also when original ideas or data from the source are not acknowledged. A bibliography is insufficient to establish which portions of the student's work are taken from external sources; footnotes or other recognized forms of citation must be used for this purpose.

2. **Cheating** at tests or examinations includes but is not limited to dishonest or attempted dishonest conduct such as speaking to other candidates or communicating with them under any circumstances whatsoever; bringing into the examination room any textbook, notebook, memorandum, other written material or mechanical or electronic device not authorized by the examiner; writing an examination or part of it, or consulting any person or materials outside the confines of the examination room without permission to do so, or leaving answer papers exposed to view, or persistent attempts to read other students' examination papers.

3. **Other academic misconduct** includes, but is not limited to, tampering or attempts to tamper with examination scripts, class work, grades and/or class records; failure to abide by directions by an instructor regarding the individuality of work handed in; the acquisition, attempted acquisition, possession, and/or distribution of examination materials or information not authorized by the instructor; the impersonation of another student in an examination or other class assignment; the falsification or fabrication of clinical or laboratory reports; the non-authorized tape recording of lectures.

4. Any student who voluntarily and consciously aids another student in the commission of one of these offences is also guilty of academic misconduct.
