#### **DESCRIPTION**

This German language class focuses on the improvement of listening and speaking skills through the critical and creative engagement with contemporary German texts, from media to fiction.

### **OBJECTIVES**

- Students will improve their German reading and writing skills.
- Students will strengthen their abilities to improve their work in collaboration with peers.
- Students will improve their ability to reflect on the principles guiding their work and to make them transparent to their audience.
- Students will critically and creatively engage with contemporary German texts which reflect on the current societal developments.

### **OUTCOMES**

- Students will be able to extract important information from complex German audio or video sources.
- Students will be able to summarize a source, to describe its formal and stylistic features, and to comment on it in German in written form.
- When writing homework, students will be able to tie their arguments to written sources in a transparent and convincing manner.
- When translating a text, students will know how to formulate principles guiding their work.
- Students will be able to communicate productive feedback on written work presented by their peers.
- Students will be able to recognize and comment on typical formal and stylistic features of contemporary German

# **Technology Requirements:**

As per the requirements, students need to have reliable access to technology, as follows:



- A computer with a supported operating system, as well as the latest security, and malware updates;

#### **ASSESSMENT**

Homework 20% (5 at 4% each)

Presentation: 10 % Oral Exam: 30 % Participation: 40 %

**Homework:** There are 5 homework assignments. Homework assesses students' understanding of the assigned readings. Homework has to be submitted on D2L prior to the class meeting for which it was assigned, and it should be ready at hand during class meetings. Homework will be graded based on completion (a complete assignment answers all questions in grammatically complete German sentences). Late submissions will not be accepted.

**Presentations:** Students have to hold a presentation (10 minutes, +/- 10%). Presentations will be graded based on content (5%), and speaking skills like pronunciation and grammatical correctness (5%)

**Participation:** Students are asked to participate in class discussions by sharing results of their homework and/or providing additional comments and questions. To receive a perfect grade, students must make substantive contributions in German every session over the course of the semester.

## Exam:

There will be 1 oral exam (max. 10 minutes). The exam will be graded based on the level of German (15%), and an understanding of the topic (15%) The oral exam will take place in the last week of classes during class time.
