## **DESCRIPTION:**

INDG 303.02. Plains Cree Part 2 is a 3-unit university-level course that provides instruction at the continuation of the Introductory level of Part 1. Students will focus on the spoken use of Plains Cree Y Dialect including basic conversation, greetings, introductions, prayers, household vocabulary and an introduction to the Plains Cree orthography.

### **OBJECTIVES:**

To provide an overview of and increase Cree vocabulary and grammar through practice and written exercises; develop some degree of oral fluency; strengthen understanding of grammatical structures; improve pronunciation of Cree. Natural Cree expressions are emphasized, where language and culture are intertwined.

### **OUTCOMES:**

Students will practice Plains Cree immersion speaking within the classroom environment and gain an understanding of how to continue with their language learning outside of their academic program. With successful completion of the course, students will gain the vocabulary and tools to understand and produce written and spoken Cree with a focus on these topics:

- Greetings, introductions, and partings
- Dates
- Money
- Occupations
- Clothing
- Animals
- Traditional food and preparation
- Natural phenomena
- Geographic directions
- Months of the year
- Cree predictions
- Cree etymology
- Kinship

**Homework Assignments:** Weekly homework assignments will be due each week at the start of class time. Homework will be graded for completion and correctness. Late homework will lose one point for each day that it is later, if you have not helped your instructor to understand that your work will be submitted late (thus homework that is marked out of 10 and due on Thursday, February 10 will be marked out of 9 if it is handed in on Friday, February 11).

**Tests:** Written tests will evaluate students' knowledge of the Cree vocabulary and grammatical structures practiced and learned lessons on which the tests are based. In addition, the tests will be cumulative, such that materials studied and learned on Test 1 may appear on Test 2, and so on. The tests will be 45 minutes each and will take place during class time in the first-half of the class period.

As Test 1 will occur during instruction over Zoom, this timed assessment will be available on D2L at the beginning of class on February 3<sup>rd</sup>, 2022 and will be available for 24 hours. When you access the assessment, you will have the length of the class (165 minutes) to complete and submit it. This assessment will consist of questions about animate/inanimate nouns and verbs, as well as word, phrase, and sentence translations from English to Cree and from Cree to English. The test will primarily cover material in Units 8 to 13. If you experience an issue that affects your ability to complete the assessment, which can include (but is not limited to) issues with technology, caregiving responsibilities, or distractions within your test-taking environment, you will need to contact your instructor as soon as possible to arrange an alternate or (in the case of technical issues) extended time to write the assessment

The week before each test, the instructor will post the format of the test on D2L. The instructor will explain each section and the marking criteria to the students. Each test is divided into several sections and may include questions on vocabulary, grammatical structures, and readings. The tests may also include review questions from previous units. No books, notes or dictionaries are allowed.

**Class Participation:** Class sessions are your primary opportunity for practicing and speaking Cree, and regular participation will be emphasized in the course. Participation includes speaking up during class sessions and volunteering to ask and answer questions.

**Flash Cards:** As with Introductory Cree Part 1, flash cards will continue to be required. Please ask your instructor if you have questions about what should be on the flash cards.

**Introductory Cree Project and Presentation:** In the last week of the term, students will give short presentations. They will be done alone/with a partner. Though, if done with a partner, students will earn individual marks. Students will be assessed on their presentation, pronunciation, grammar, and creativity. Further details will be provided in person. If you experience speech anxiety, you will have the option to give your presentation as a video. The same criteria mentioned above will be applied. Please confirm with your instructor if you will give your presentation in person or by video at least two weeks before the day when the presentation is due to be given.
