DESCRIPTION

A continuation of Ital 301, this course is a further development of communication skills in Italian (listening, speaking, writing and reading), as well as the study of cultural issues in the Italian world with emphasis in reading.

Class participation is essential. All classes are conducted in Italian.

PREREQUISITE(S) :

Italian 301 or consent of the Department.

Note: Enrollment in any higher level Italian course requires a grade of at least "C-" in the prerequisite course(s), or consent of the Department.

- b) parts of the work are taken from another source without reference to the original author;
- c) the whole work (e.g., an essay) is copied from another source, and/or
- d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted."

Plagiarism occurs not only when direct quotations are taken from a source without specific acknowledgement but also when original ideas or data from the source are not acknowledged. A bibliography is insufficient to establish which portions of the student's work are taken from external sources; footnotes or other recognized forms of citation must be used for this purpose.
