DESCRIPTION

This intensive course will introduce students to the art and culture of Italy through a series of lectures and field trips on site: topics are related to peace studies, environment, art history, film and poetry.

This course is part of the collaboration between the University of Calgary and the University of Foreigners in Perugia. The course is conducted mostly in Italian. Course load is 14 hours a week. It can only be taken in conjunction with ITAL 301, ITAL 203 or ITAL 303.

Prerequisite:

ITAL 203 or acceptance into the University of Calgary, Perugia program.

- Students will be placed in different classes accordingly to the placement exam that will take place at the University for Foreigners in Perugia prior to the beginning of classes.
- **Final project:** the topic of this short research paper will be agreed with the instructor. It will have a length of 2-3 pages, in English, and it will refer to subjects covered in class and during field trips
- Due to the nature of the course, attendance is mandatory (for both classes and field trips).
