**DESCRIPTION**

The course is intended as a further introduction to the basics of the Russian language, including its grammatical structure and its differences from, as well as similarities with English; it is organized thematically. Close attention is paid to all language skills: listening, speaking, reading and writing. Cultural and historical facts form an integral part of the course, and contribute to creating the necessary context in which Russian operates.

**Prerequisites:** Russ 201 or permission of the School

**OBJECTIVES**

The course will build on the material studied in RUSS 201 and will cover the grammar and the vocabulary enabling the students to carry out a range of everyday simple conversations in Russian.

#### COURSE EXPECTATIONS

***Students with prior knowledge of Russian must consult the Russian undergraduate program advisor in order to be placed in a course suitable for their level. Students are advised that misrepresenting their level of Russian language knowledge constitutes academic dishonesty and will be dealt with as such.***

This being a language class, regular attendance and timely homework submission are expected and necessary for steady progress. The instructor should be informed of any reasons for prolonged absence.

Homework for the week is expected to be handed the following Monday at the latest. Regular homework is of utmost importance in order to follow the pace and succeed in this course.

Missed tests, quizzes and assignments will be given a grade of F unless a student can show that the absence was for legitimate reasons.

Students are strongly encouraged to participate in group study sessions outside class led by an advanced student of Russian.

#### ACADEMIC MISCONDUCT

1. **Plagiarism** is a serious offence, the penalty for which is an F on the assignment and possibly also an F in the course, academic probation, or requirement to withdraw. Plagiarism exists when:

- a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test);
- b) parts of the work are taken from another source without reference to the original author;
- c) the whole work (e.g., an essay) is copied from another source, and/or
- d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted." Plagiarism occurs not only when direct quotations are taken from a source without specific acknowledgement but also when original ideas or data from the source are not acknowledged. A bibliography is insufficient to establish which portions of the student's work are taken from external sources; footnotes or other recognized forms of citation must be used for this purpose.

2. **Cheating** at tests or examinations includes but is not limited to dishonest or attempted dishonest conduct such as speaking to other candidates or communicating with them under any circumstances whatsoever; bringing into the examination room any textbook, notebook,

memorandum, other written material or mechanical or electronic device not authorized by the examiner; writing an examination or part of it, or consulting any person or materials outside the confines of the examination room without permission to do so, or leaving answer papers exposed to view, or persistent attempts to read other students' examination papers.

3. **Other academic misconduct** includes, but is not limited to, tampering or attempts to tamper with examination scripts, class work, grades and/or class records; failure to abide by directions by an instructor regarding the individuality of work handed in; the acquisition, attempted acquisition, possession, and/or distribution of examination materials or information not authorized by the instructor; the impersonation of another student in an examination or other class assignment; the falsification or fabrication of clinical or laboratory reports; the non-authorized tape recording of lectures.

4. Any student who voluntarily and consciously aids another student in the commission of one of these offences is also guilty of academic misconduct.
