**Descripción**

Spanish 598 Spanish Honours Thesis se concentra en el estudio de la obra de Violeta Parra, compositora, cantante, instrumentista, folclorista y artista plástica chilena. Este curso y la escritura de una tesis de honor, se enfocará en el análisis de las composiciones poético-musicales de esta afamada artista.

En cuanto a las fuentes primarias para la lectura y el estudio o tesis, existe una amplia gama de letras de canciones, de alta calidad poética, a la vez que ejemplos de profunda reflexión existencial y social. Su obra también abarca una gran cantidad de composiciones recolectadas por la misma artista en numerosos viajes de investigación que realizó en ciudades y zonas rurales de Chile. Existe, asimismo, una amplia gama de estudios de la obra musical de Violeta Parra, biografías y abundantes alusiones a la influencia de su obra en la música chilena y latinoamericana. Todos estos materiales componen la fuente bibliográfica principal para el estudio de la obra de esta autora.

Otro aspecto crítico que ayudará a enfocar las lecturas y la tesis, es el movimiento, tanto literal como poético, simbolizado en la figura de la “caminante,” el sujeto biográfico y el representado en los cantos, que se mueve entre la ciudad y el campo para recolectar las tradiciones y ser testigo en muchos casos de las difíciles condiciones de vida de los habitantes. En la escritura de Violeta Parra, y teniendo en cuenta a este ser peripatético que va a la búsqueda de conocimiento, se unen el amor, el dolor, la separación sentimental, la denuncia social y la reflexión sobre la vida para conformar una ética del canto o, más directamente, para la propuesta de una actitud que es, por un lado, consecuente con los imperativos que impone la creación en cuanto a la calidad de la escritura poético-musical y que, por otro, es fiel a los lazos de solidaridad que la unían a los campesinos y a los trabajadores chilenos.

El estudiante va a hacer una lectura crítica de las obras mencionadas en la lista, leerá la crítica y otros textos apropiados, y completará el curso con la escritura de un ensayo de 30 a 40 páginas, proyecto final o “tesis de honor.”

## ACADEMIC MISCONDUCT

1. Plagiarism is a serious offence, the penalty for which is an F on the assignment and possibly also an F in the course, academic probation, or requirement to withdraw. Plagiarism exists when:
- a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test);
  - b) parts of the work are taken from another source without reference to the original author;
  - c) the whole work (e.g., an essay) is copied from another source, and/or
  - d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.
- While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.”
- Plagiarism occurs not only when direct quotations are taken from a source without specific acknowledgement but also when original ideas or data from the source are not acknowledged. A bibliography is insufficient to establish which portions of the student's work are taken from external sources; footnotes or other recognized forms of citation must be used for this purpose.
2. Cheating at tests or examinations includes but is not limited to dishonest or attempted dishonest conduct such as speaking to other candidates or communicating with them under any circumstances whatsoever; bringing into the examination room any textbook, notebook, memorandum, other written material or mechanical or electronic device not authorized by the examiner; writing an examination or part of it, or consulting any person or materials outside the confines of the examination room without permission to do so, or leaving answer papers exposed to view, or persistent attempts to read other students' examination papers.
3. Other academic misconduct includes, but is not limited to, tampering or attempts to tamper with examination scripts, class work, grades and/or class records; failure to abide by directions by an instructor regarding the individuality of work handed in; the acquisition, attempted acquisition, possession, and/or distribution of examination materials or information not authorized by the instructor; the impersonation of another student in an examination or other class assignment; the falsification or fabrication of clinical or laboratory reports; the non-authorized tape recording of lectures.
4. Any student who voluntarily and consciously aids another student in the commission of one of these offences is also guilty of academic misconduct.
