DESCRIPTION

An in-depth reading and analytical study of Miguel de Cervantes' prose novel, *El ingenioso hidalgo don Quixote de la Mancha* (1605 & 1615) in the original Spanish. Special attention will be paid to the language of the text in its early seventeenth-century linguistic, societal, historical, literary, and other cultural contexts. Students will be responsible for reading the primary text and, possibly a few, short critical works. The final research paper, preferably short in length but brilliant in design and presentation, must be based on the original text.

Prerequisites

Spanish 405 (or 401), 407 (or 403), 421 and 423 or consent of the Department.

OUTCOMES STATEMENT:

At course's end, the student who has completed all of the reading and has participated actively in all in-class and out-of-class discussions, will have carefully digested and understood what arguably is the greatest novel of all, *El ingenioso hidalgo don Quixote de la Mancha*. The student will learn how society and literary text are interrelated, and will be able to intelligently and professionally evaluate the novel. As a direct consequence of writing the two examinations and the final research paper, the student will have arrived at a level of analytical, organizational, grammatical, and syntact competence considerably higher than that at the onset of the course. And, naturally, the student will have enjoyed the experience.

- b) parts of the work are taken from another source without reference to the original author;
- c) the whole work (e.g., an essay) is copied from another source, and/or
- d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted." Plagiarism occurs not only when direct quotations are taken from a source without specific acknowledgement but also when original ideas or data from the source are not acknowledged. A bibliography is insufficient to establish which portions of the student's work are taken from external sources; footnotes or other recognized forms of citation must be used for this purpose.
